Fetal spiral electrodes (updated August 20)

All Cardinal supply challenge have recovered and products are available to order.

Current conditions

In November 2022, Philips became aware of a *potential* safety issue with the Fetal Spiral Electrode based on an increasing number of customer complaints related to the spiral tip of the FSE breaking off during use. As a result, the FDA issued a Class II Correction (Recall) of the Fetal Spiral Electrode.

- Philips has exited the market for Fetal Spiral Electrodes; however, they still make the monitors.
- DECG Legplate Adapter Cable and Attachment Electrode were discontinued 12/31/2022

Due to the limited number of alternative products available, Cardinal has proactively increased their forecast expectations to allow them to better support the full anticipated market need. All Cardinal supply challenge have recovered and products are available to order.

Recall mitigation strategy

For the Philip's recall, providers should complete the Urgent Field Safety Notice Response Form online to submit both their acknowledgement of this recall (mandatory) and actions taken, as well as request for credit (optional). To request credit, go to URL: https://forms.office.com/r/GsLVh2gYZi.

If you choose, discard all FSEs sold by Philips and source from an alternative supplier available in your country. If you choose to discard the FSEs, we will issue a credit after you complete the online response form.
