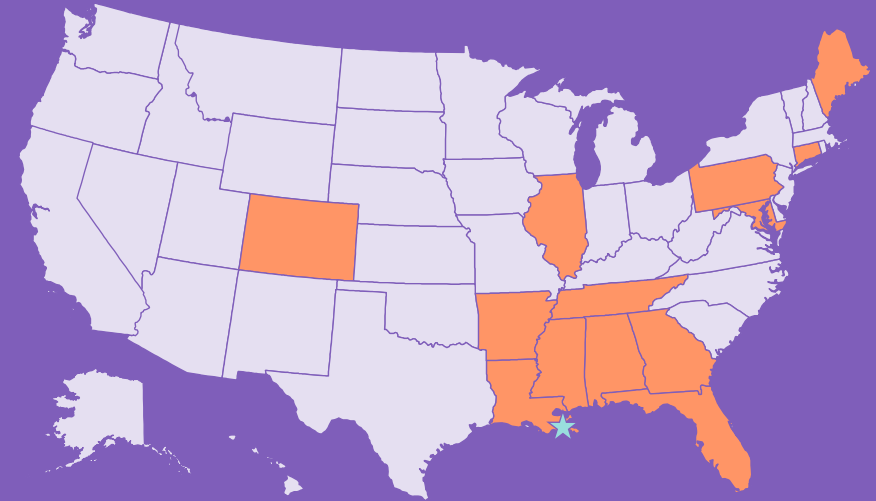


Southern Strategic Sourcing Partners (S3P)



The Southern Strategic Sourcing Partners (S3P) is a pharmacy aggregation group comprised of 73 health systems, representing 588 acute care **facilities** and over **\$2 billion** in annual pharmacy spend. Since inception in 2018, member hospitals have achieved more than **\$60 million** in implemented savings. The pharmacy aggregation group is led by the S3P Pharmacy Steering Committee which is comprised of 13 pharmacy leaders providing a diverse representation of the full Member hip. S3P attains savings by focusing on contracting agreement opportunities.

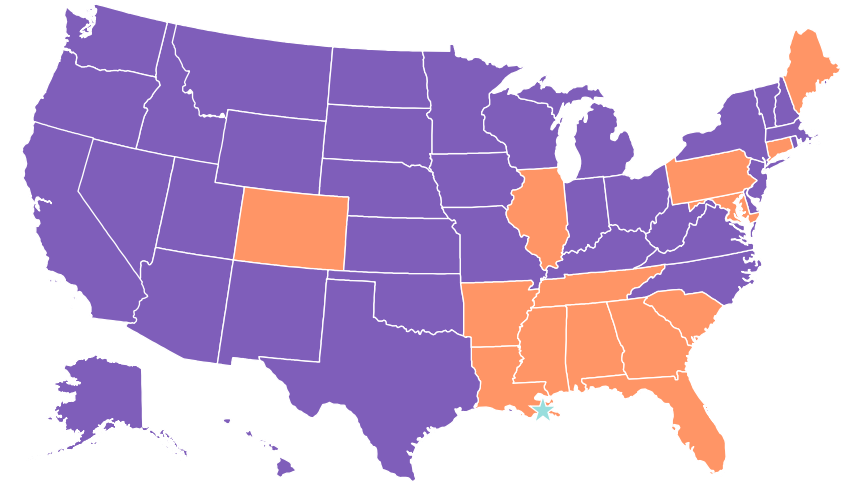
- Sharing of knowledge across Member to help address challenges such as regulatory and practice issues, service evaluation and growth opportunities

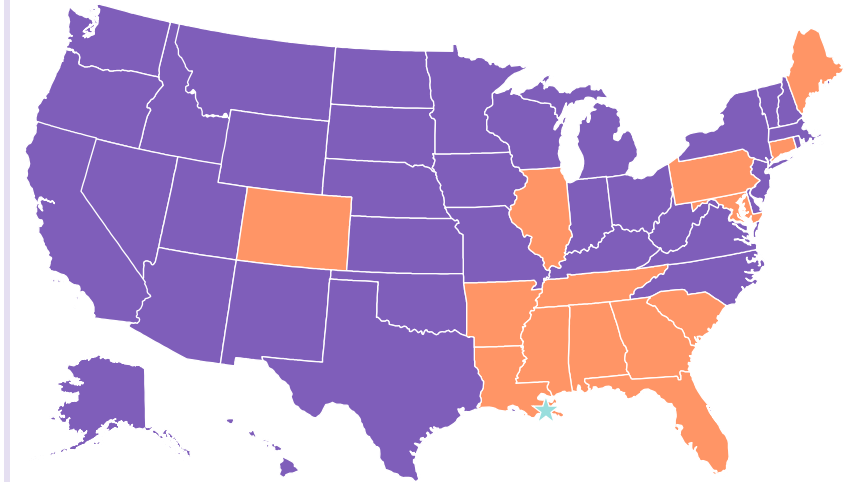

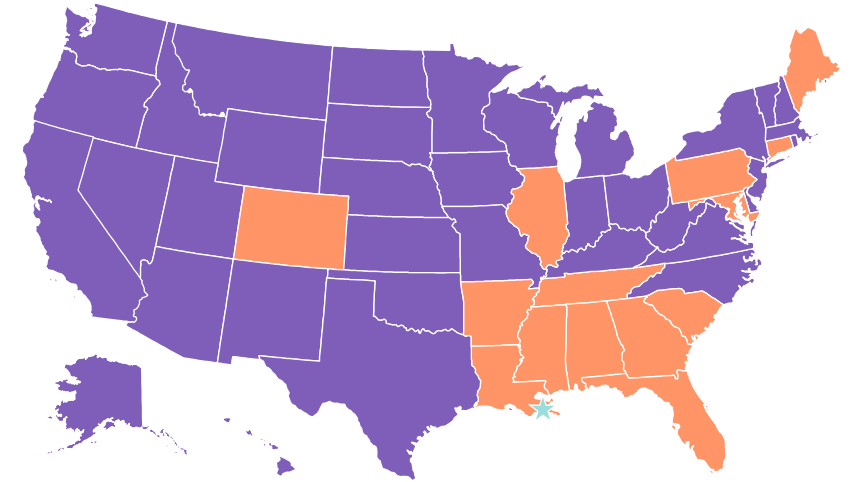
