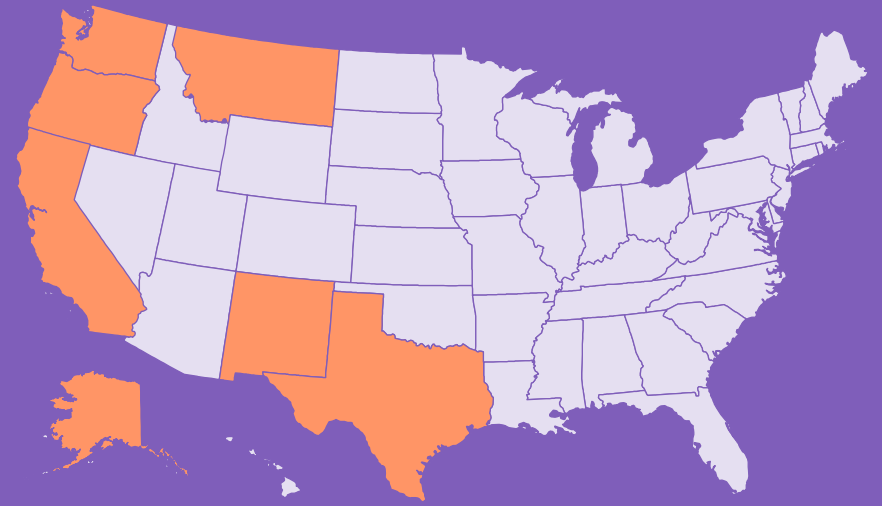


# Providence Pharmacy Network (PPN)



The Providence Pharmacy Network (PPN) Network is a pharmacy aggregation group consisting of large system of 55 acute care hospitals with associated infusion centers, ambulatory clinics and home care services spanning 7 states, which are categorized into 7 regions. Since the inception of the PPN Pharmacy Network in February of 2020, total savings of **\$24.8 million** has been achieved. Drug cost savings and cost avoidance have been gained through both utilization/standardization and contracting. A continued focus on drug cost savings, revenue enhancement and network growth is planned with foundational operating guidelines to vet and on-board new Member . The PPN Pharmacy Network team governance consists of executive pharmacy leaders representing clinical, operational, and financial/contracting areas under the Chief, Pharmacy Officer. In recognition of their excellent work, the PPN Pharmacy Network team Member are the proud recipients of the first Vizient Pharmacy Vision Award for Excellence in Network Sourcing and Aggregation in 2021.

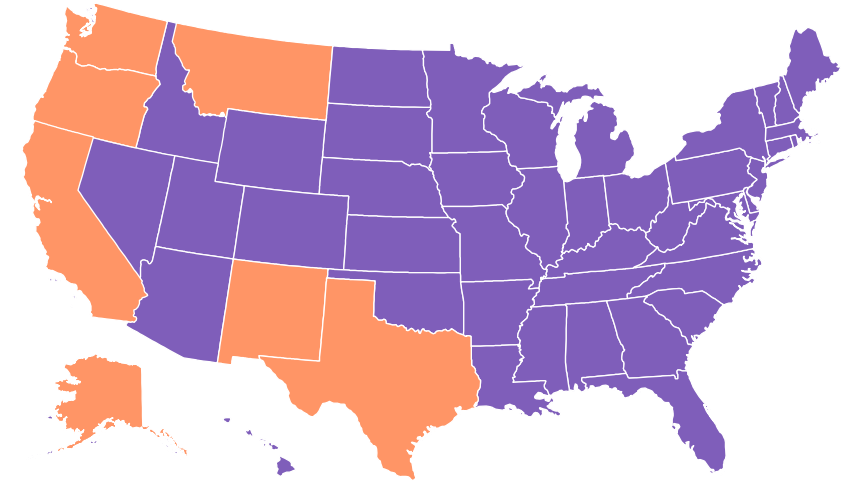

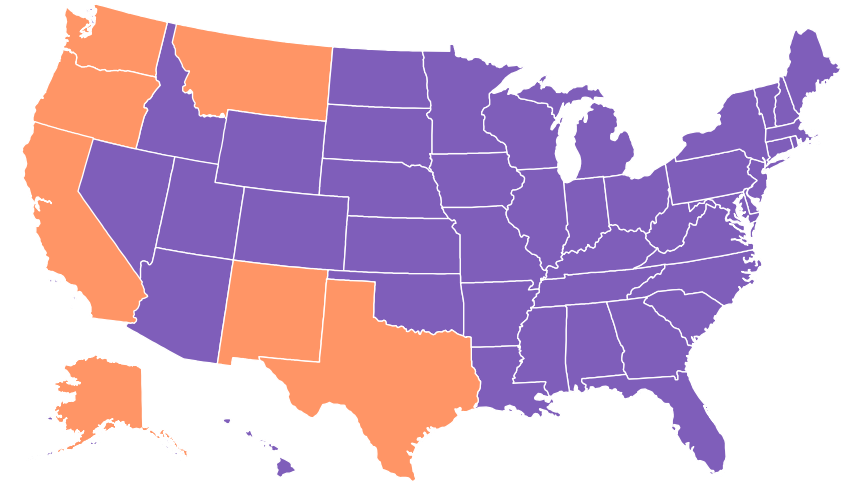

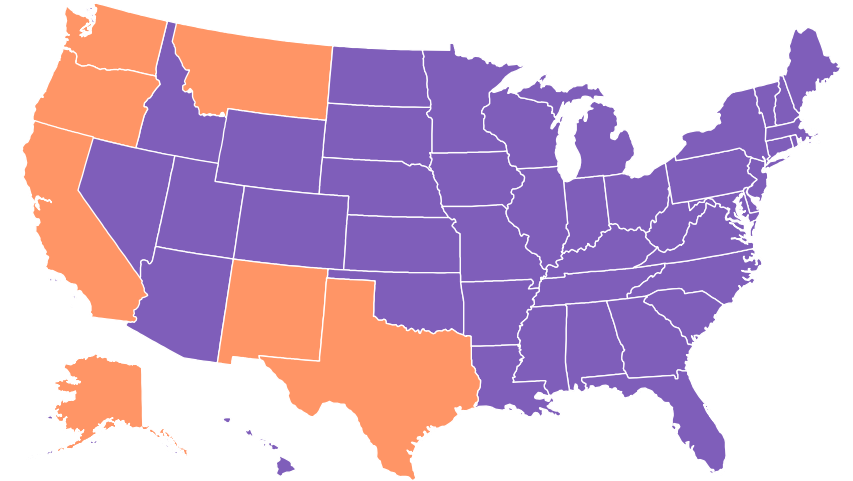
