### Interprofessional Continuing Education (IPCE)

## Nurses (CNE)

## Physicians (CME)

## Physician Associates (AAPA)

## Registered Dietitians (RDs) and Dietetic Technicians, Registered (DTRs) (CDR)

## Healthcare Executives (ACHE)

## Healthcare Quality Professionals (CPHQ)

This activity is pending approval by NAHQ<sup>®</sup> for 14.25 CPHQ CE credits.

Participants must self-report the CE they earned into their current recertification cycle.

## Other Healthcare Professionals (General CE Credit)

Vizient, Inc. will award all other healthcare professionals who successfully complete an activity a Certificate of Participation. Various state license boards and credentialing bodies accept certificates of participation from accredited CE activities to meet CE requirements for license renewals and re-certification. It is the responsibility of the participant to contact their state licensing board and/or certifying body for verification on credit eligibility reciprocity.
