Through the Pharmacy Price Verification program, Vizient® pharmacy program participants get the benefits of automated monitoring and centralized cost recovery to ensure that the full value of the Vizient pharmacy contract portfolio is realized.

Our team reviews your pharmacy wholesaler spend to confirm that you receive the correct contract price on purchases for which there is a Vizient contract. If we find that the wholesaler has incorrectly charged a price for a Vizient contracted product, we work with the wholesaler and supplier on your behalf to reconnect the contract price and recoup the credit for which you are eligible. The result is a direct reduction in your pharmacy costs.

Multiple layers of coverage

Price verification is performed for all pharmacy program participants. Additional layers of coverage are also available through subscription.

Participation in the **Vizient pharmacy program** includes non-contract to contract price verification.

Subscription to Pharmacy Analytics includes additional coverage:

- **Tier-to-tier:** Corrects pricing when the customer receives the wrong tier
- **DSH:** Corrects pricing when the customer qualifies for GPO DSH pricing
- **Price-to-price:** Corrects pricing when the wholesaler has the wrong price loaded

Enhanced Price Verification subscription includes all coverage from above as well as **single-aggregation group agreements** and **multi-aggregation group agreements**: Corrects pricing for customers participating in a Vizient Pharmacy Aggregation Groups program agreement

Transparency and tracking

Price verification takes place behind the scenes for all pharmacy program participants and all classes of trade. Monthly credits and returns generated can be viewed in the Pharmacy Value Tracker (PVT), which reports the following:

- Total net credits collected and net provider returns from share-back
- Recovered provider credits down to the product level
- Monthly updated value

The PVT is provided to pharmacy program participants monthly through Vizient field representatives. You can also review performance metrics and detailed reporting within Pharmacy Analytics.
